Terms of Use for Digitization on Demand Contract:

§ 1 Purpose
 The purpose of these terms of use is, on the one hand, that the purchaser can use the provided digital image for their own purposes, and on the other hand, that SBB (Staatsbibliothek zu Berlin) can make use of these files to fulfill its public service mission. This means that SBB may utilize the digital images produced as follows:
 a) make them publicly available on the Internet in the context of digital presentation.
 b) grant rights to third parties, and
 c) grant rights to all potential users through an open-content license

§ 2 Non-commercial Use
 The reproductions provided are intended for non-commercial use only. In the event of publication, the purchaser is obliged to submit a copy to SBB. The purchaser grants all copyrights in the works exclusively to Stiftung Preußischer Kulturbesitz. This particularly concerns the rights which he/she has possibly acquired, according to § 71 UrhG, by reason of first publication, or the public display of a previously unpublished work.
